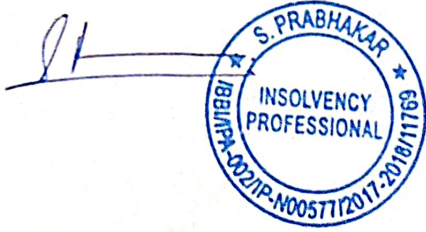

Chargesheets filed against Anil, Rana Kapoor by CBI in graft case

New Delhi: The CBI filed a chargesheet on Thursday against Anil Ambani and others over alleged fraudulent transactions between the industrialist's group companies, FL and RIFL. You Bank and firms of the bank's former CEO Rana Kapoor's family causing a loss of ₹2.26 crore to the bank, officials said.

In its chargesheet filed in a special court in Mumbai, the local agency has said Anil Ambani is the chairman of the Adani Group and Anil Ambani (ADA) Group and director of Reliance Capital Limited, the holding company of FL and RIFL.

No comments from the ADA group were immediately available. Besides Anil, the Central Bureau of Investigation (CBI) has chargesheeted Rana Kapoor, Rohini Kapoor, Radha Kapoor, Roshni Kapoor, FL RIFL (now Anshu), Morgan Investment Infrastructure Limited, RAB Enterprises Private Limited, Imagine Estate Private Limited, Bliss House Private Limited, Imagine Habitat Private Limited, Imagine Residential Private Limited, Morgan Credits Private Limited under sections of the Prevention of Corruption Act and Indian Penal Code (IPC).

The CBI registered two cases in 2022 against Kapoor, the then managing director and CEO of the Yes Bank, Reliance Commercial Finance Limited (RCFL) and Reliance Home Finance Limited (RHFL) on a complaint from the bank's chief vigilance officer.

'Moonwalk' cop taken off duty for 'inappropriate' conduct

Indore: A traffic policeman in Indore, famous on social media for his 'moonwalk' dance steps on the roads of Madhya Pradesh's commercial capital, was on Thursday taken off field duty for allegedly sending an inappropriate message to a woman, a senior official said.

Traffic head constable Ranjit Singh was removed from field duty and attached to the police lines for his alleged misconduct, additional deputy commissioner of Police Rajesh Dandoliya said.

"We have learnt that Singh sent inappropriate messages to a woman on social media. I will be heading an inquiry against him. A report will be submitted to superior authorities for suitable action based on evidence," the Additional DCP said.

In a video post on social media, the woman said Singh directly messaged her after a brief online introduction, invited her to visit Indore and offered to arrange her flight tickets.

The woman said she warned the constable to not meet her again and also admonished him for sending such a message.

No violation, says Sebi; Adani seeks apology for false claims'

Delhi court sets aside order asking scribes to take down content against Adani co

New Delhi: A Delhi district court on Thursday set aside an order asking four journalists to take down allegedly defamatory content against Adani Enterprises Limited (AEL). District Judge Ashish Agarwal allowed a plea filed by four journalists, Ravi Nar. Abir Dasgupta, Ayasanta Das and Ayush Joshi, challenging an order restraining them from publishing or circulating alleged unverified and defamatory content against Adani Enterprises Limited. The court was asked to issue an order directing the four journalists against a civil judge's Sept 6 order.

As a result, Sebi concluded that there was no basis for assigning liability or imposing penalties on the Adani entities or executives. Adani reacted to the decision by calling for an apology by those who spread false narratives using Hindenburg Research's 'fraudulent and motivated' report.

In a post on social media, Adani said the Sebi decision has reaffirmed what his group has always maintained — "that the Hindenburg claims were baseless."

"Transparency and integrity have always defined the Adani Group," the Adani Group Chair said. "We deeply feel the pain of the investors who lost money because of this fraudulent and motivated report. Those who spread false narratives over the nation an apology," he said.

Adani reacted to the decision by calling for an apology by those who spread false narratives using Hindenburg Research's 'fraudulent and motivated' report.

In a post on social media, Adani said the Sebi decision has reaffirmed what his group has always maintained — "that the Hindenburg claims were baseless."

Pakistan-Saudi pact based on Islamic solidarity, close def ties

The agreement came after four months of intense military-to-military talks between India and Pakistan in May. According to the Pakistan-Saudi joint statement, the pact builds on the historic partnership extending for nearly eight decades between Saudi Arabia and Pakistan, and is based on the bonds of brotherhood and Islamic solidarity, as well as shared strategic interests and close defence cooperation between the countries.

The two sides also reviewed the historic and strategic relations between both countries and several topics of common interest.

Woman Naxalite with ₹5L bounty killed in encounter

Sukma: A woman Naxalite was killed in an incident of violence and carrying a reward of ₹5 lakh on her head was killed in an encounter with security personnel in Chhattisgarh's Sukma district on Thursday, police officials here said. The gun battle broke out in the morning on a road to a forested hill between Gudi and Permapara villages, when a unit of state police, was out on a search operation and a Naxalite was spotted.

Meanwhile, Maoists abducted and killed a 25-year-old man on suspicion of being a police informer in Madhya Pradesh's Balaghat district, an official said on Thursday.
